*Robbery*: Reduced to wobbler offense, Electronic Monitoring, No  
Jail, LAX Courthouse

*Federal Real Estate Fraud*: Client facing up to 10 years in prison,  
probation with no jail time, Central District California

*Federal Wire Fraud*: Diversion with no felony conviction, North  
Carolina
